#### 1 Introduction

- 1.1.1 Highways England is a government-owned company responsible for operating, maintaining and improving England's motorways and major A-roads. We are undertaking billions of pounds of investment on the strategic road network. The A12 Chelmsford to A120 widening scheme (the proposed scheme) will improve journeys between junction 19 (Boreham Interchange) and junction 25 (Marks Tey Interchange).
- 1.1.2 This Statement of Community Consultation (SoCC) sets out how we will consult local communities for the proposed scheme. It provides details about how you, residents, businesses and interested parties, can take part in the consultation and how feedback from consultees will be used to influence our proposed design.
- 1.1.3 To make sure we approach our consultation in the very best way for the local communities, we have consulted the following local authorities in the area of the proposed scheme on a draft version of this SoCC:
  - Braintree District Council
  - Chelmsford City Council
  - Colchester Borough Council
  - Essex County Council
  - Maldon District Council
- 1.1.4 We issued a draft version of this SoCC to those local authorities in accordance with Section 47(2) of the Planning Act 2008. The local authorities listed above were consulted because the proposed scheme will pass through their local authority area.
- 1.1.5 This document also gives you the background to the proposed scheme and how our application to construct it will progress.




## 2 Our application

- 2.1.1 The proposed scheme is being developed under the Planning Act 2008 and we are publishing this SoCC under Section 47 (duty to consult local community) of that Act.
- 2.1.2 Under the Planning Act 2008, we are required to make an application to the Secretary of State through the Planning Inspectorate for a Development Consent Order (DCO) to build the proposed scheme. The Planning Inspectorate will examine our application, and the Secretary of State will decide whether the proposed scheme should go ahead, based on a recommendation made by the Planning Inspectorate. We anticipate that our DCO application for the proposed scheme will be submitted in spring/summer 2022.
- 2.1.3 A key consideration for the Planning Inspectorate and the Secretary of State when assessing our DCO application is the National Policy Statement for National Networks. The National Policy Statement sets out the need to develop road projects on the national network and is the policy document against which decisions on major road projects is made.
- 2.1.4 In addition, within the proposed scheme, there are a range of utilities that will be affected, including the diversion of a number of high pressure gas pipelines that form part of the proposed scheme. To the extent that these diversions satisfy the criteria to be categorised as an NSIP under the Planning Act 2008, they will be considered NSIPs in their own right. This means that the diversions would also be considered against the relevant energy National Policy Statements within the application.
- 2.1.5 When we submit our DCO application, one of the key areas the Planning Inspectorate must consider is whether our pre-application consultation has been adequate. The best time for you to have your say to inform our final design on the proposed scheme is now, by taking part in this consultation.

## 3 The proposed scheme

- 3.1.1 The A12 is an important economic link in Essex and across the east of England, and part of the Highways England strategic road network. It provides the main south-west–north-east route through Essex and Suffolk, connecting Ipswich to London and to the M25.
- 3.1.2 The section between junction 19 (Boreham Interchange) and junction 25 (Marks Tey Interchange) carries high volumes of traffic, with up to 90,000 vehicles every day. Heavy Goods Vehicles make up between 9% and 12% of the traffic on this section as it is an important freight connection, especially to Felixstowe and Harwich ports which are key economic links between the UK and the global supply chain. This section of the A12 is also an important commuter route between Chelmsford and Colchester. The resulting congestion leads to delays and means that, during the morning commute, a driver's average speed is particularly slow in both directions for a dual-carriageway A-road of its kind.
- 3.1.3 The proposals widen the existing A12 between junctions 19 and 25 to three lanes in each direction (where it is not already) and create a three-lane bypass in each direction at Rivenhall End (between junctions 22 and 23) and a second bypass between Feering and Marks Tey (between junctions 24 and 25). This route reflects the feedback we received on junctions in our first consultation in 2017, as well as comments about the Rivenhall End bypass being close to the Rivenhall Long Mortuary Enclosure scheduled monument. Our application will cover all the work necessary to construct, operate and maintain the proposed scheme.
- 3.1.4 Our proposed changes to this stretch of the A12 road will:
  - improve safety for road users, especially at the junctions and slip roads through better design while also removing the current direct private accesses onto the A12
  - reduce traffic congestion by increasing the capacity of the road, making journey times more reliable. The proposed scheme will save motorists as much as 1.5 hours in a working week if they travel daily between junctions 19 and 25
  - take long-distance traffic off the local roads and put it back onto the A12 where it belongs, so that local roads aren't used as rat runs, affecting local villages and their communities
  - ensure that the road can cope with the predicted increase in traffic from more jobs and homes in the area
  - make improvements for walkers, cyclists, horse riders and public transport users, to give them better connections and safer, more enjoyable journeys



## 4 Preliminary Environmental Information Report

- 4.1.1 Due to the size and nature of the proposed scheme, we are required to undertake an environmental impact assessment (EIA) for the scheme. The EIA will form the environmental statement that will be submitted as part of the application for the scheme. As part of this statutory consultation we have published a Preliminary Environmental Information Report (PEIR) on the proposed scheme webpage (<a href="www.highwaysengland.co.uk/A12">www.highwaysengland.co.uk/A12</a>) as part of the consultation materials available. The PEIR gives information about the potential environmental effects of the proposed scheme and the measures put forward to reduce any significant adverse effects identified. It addresses the full range of environmental topics including air quality, noise, water, soils, landscape, biodiversity, heritage, population and health, and climate change.
- 4.1.2 The PEIR provides information at an interim stage in the Environmental Impact Assessment process, and responses received to this consultation will help inform the continued development of the proposed scheme and the production of a final Environmental Statement to support the application for development consent. We have also published a non-technical summary of the PEIR to better enable the local community to understand the environmental effects of the proposed scheme.
- 4.1.3 As part of the pre-application consultation, the general public and statutory consultees will be able to comment on the content of the PEIR.
- 4.1.4 Additional information about the proposed scheme, including detailed maps/plans and associated benefits are included in our public consultation brochure.

# 5 Consulting the community and previous consultations

- 5.1.1 In 2017, we consulted on four possible route options to widen the A12. Consultees were asked for their views on the four route options, which included two online and two offline routes. They were also asked about individual junction improvements.
- 5.1.2 Following the consultation in 2017, the local authorities of Colchester, Braintree and Tendring put forward a joint local plan, including the Colchester Braintree Borders Garden Community which affected the route options we consulted on in 2017 (mainly between junctions 23 and 25). We therefore consulted on alternative routes between junctions 23 and 25 in our 2019 consultation which took account of the area for the proposed garden community. In parallel, we announced the preferred route between junctions 19 and 23 which was unaffected by the garden community proposals. This was based on option 2 from the 2017 consultation. However, in May 2020, the Planning Inspectorate made their recommendation that the proposed garden community should be removed from the joint local plan and the councils accepted this recommendation.
- In August 2020, we therefore announced the preferred route between junctions 23 and 25 based on option 2 from the 2017 consultation. The preferred route was selected based on several factors, including: environmental impacts; journey times; complexity of build; affordability; feedback from the public, and the decision by the local authorities to remove the Colchester Braintree Borders Garden Community proposals from the joint Local Plan for that area. - 5.1.4 Since then, we have held numerous meetings and workshops with local planning authorities, parish councils and customers.

#### 6 About this consultation

- 6.1.1 It is important to us that our consultation:
  - enables members of the public to influence our proposals
  - provides the opportunity for everyone, including hard to reach individuals and groups, to give feedback on our proposals
  - encourages the community to help shape our proposals to maximise local benefits and minimise any downsides by sharing their views
  - helps local people understand the proposed scheme and local impact of our proposals
  - enables potential mitigation measures to be considered and, if appropriate, built into the proposed scheme before our DCO application is submitted
  - identifies ways in which our proposals support wider strategic or local objectives
- 6.1.2 Your comments will help us achieve these objectives. We commit to listen to everyone's view, and we will consider all your opinions before we submit our DCO application.
- 6.1.3 The consultation will run from Tuesday 22 June 2021 until Monday 16 August 2021. During the consultation period, we will consult on the following particular elements of the proposed scheme:
  - the junctions and designs
  - environmental mitigation measures
  - traffic impacts
  - provision for walking, cycling and horse riding
- Working with Braintree District Council, Chelmsford City Council, Colchester Borough Council, Essex County Council and Maldon District Council, we have developed a target area (image 2: mailout zone) for the distribution of our consultation letters. This covers all directly affected parish council areas as well as parishes who may not be directly affected but are in close proximity to the proposed scheme. We will also promote the consultation beyond this area (please see pages 13 and 14 for more details on how we will advertise the consultation). We'll let people living in this area know about our consultation by posting a letter informing them about how they can participate, and we will also contact business premises within the target area in the same way.




Image 8.1 Example of virtual exhibition space

## 9 How to respond to the consultation

- 9.1.2 All responses must be received by 11.59pm on Monday 16 August 2021.



### 10 Next steps

- 10.1.1 Where we consider it appropriate, and before submitting our DCO application, we may choose to undertake further targeted consultation on certain changes to the proposed scheme made in response to consultation feedback or updated technical information. Such consultation will be for a minimum of 28 days.
- 10.1.2 We will record and carefully consider all responses received during this consultation and any subsequent consultation periods. All responses will be taken into account in finalising our application before we submit it to the Planning Inspectorate.
- 10.1.3 We'll summarise our findings in a Consultation Report which will include a description of how our application was informed by the responses received, and outline any changes made as a result of consultation. The Consultation Report forms part of our application to the Planning Inspectorate, as required by section 37(3) of the Planning Act 2008.
- 10.1.4 The Planning Inspectorate will decide whether the application meets the required standards to proceed to examination. It will also determine whether our consultation has been adequate.

## 11 Your data, your rights

- 11.1.1 Highways England is committed to protecting your personal information. Whenever you provide such information, we are legally obliged to use it in line with all applicable laws concerning the protection of personal data, including the General Data Protection Regulation (GDPR), which came into effect on 25 May 2018.
- 11.1.2 Highways England will use your personal data for a number of purposes, including the following:
  - To analyse the feedback that you provide in response to our consultation
  - To produce a summary report, based on our analysis of responses (individuals will not be identified in that report)
  - To write to you with updates about the outcomes of this consultation and other proposed scheme developments
  - To keep up-to-date records of our interactions with individuals and organisations
- 11.1.3 Your information will be handled and used by the following recipients in order to record, analyse and report on feedback received:
  - Highways England
  - Highways England's suppliers (delivering this scheme)
  - An analysis company (who have been contracted by Highways England to analyse feedback to the consultation)
  - The Planning Inspectorate (who will consider our application for permission to build the proposed scheme)
  - The Secretary of State (who will decide whether consent should be granted)
- 11.1.4 It is also possible that trusted third party providers, for example construction companies, may later use contact details provided in your response to communicate with you about the development of the proposed scheme.
- 11.1.5 We will keep your information for up to six months after the DCO decision has been made.
