Summary of the consultation

Topic of this consultation	Introduction of a 60mph permanent speed limit between junction 1 and just south of junction 2 on the M5.
Scope of this consultation	We are keen to have your comments on the introduction of a 60mph permanent speed limit on the M5 between junction 1 and just south of junction 2. We specifically would like to hear how the proposal could affect you, your organisation or those you represent. It is important to note that this is not a consultation on the actual policy of using permanent speed limits. We are therefore seeking your views on the proposal set out within this document.
Geographical scope	M5 main line between just north of junction 1 and just south of junction 2.

After the consultation	All responses received from consultees within the consultation period will be considered and responded to as necessary. Following the consultation, a response to consultation report will be made available on the National Highways website. The report will provide an analysis of responses received and the National Highways response. We envisage that the 60mph speed limit would be in place until the air quality in this area improves, this is specified as being where NO2 levels are not in excess of 40mg/m3 for 12 months.
Compliance with the Government's Consultation principles	The consultation complies with the Government's Consultation Principles.
Getting to this stage	A temporary 60mph speed limit is currently in place between just north of junction 1 and just south of junction 2 on the M5. This speed limit was imposed as the levels of NO2 exceeded the government's air quality target value. Therefore reducing the speed of vehicles in this section, to a maximum level where they perform more efficiently, will contribute to the reduction of NO2 in this area. National Highways is now proposing that the 60mph speed limit is made permanent by way of regulations made by statutory instrument.

Executive Summary

This consultation provides an opportunity for interested parties to comment on the proposal to introduce, by way of Regulations, a permanent 60mph speed limit between just north of Junction 1 and just south of Junction 2 of the M5. The 60mph speed limit will, if approved, be set permanently and will be clearly displayed by signs on both sides of the carriageway indicating where it starts. There will also be signs which repeat this speed limit and which indicate where it ends.

Once in force, the relevant Regulations will prohibit driving at a speed exceeding 60mph within the extents of this limit.

Benefits of a 60mph speed limit

By introducing the proposed 60mph speed limit the intention is that:

• Vehicles travelling on this route would be limited to a speed where they would perform more efficiently, reducing emissions.

We welcome comments specifically on how the proposal could affect you, your organisation or those you represent.

1. How we are conducting the consultation

1.1. What is this consultation about?

We are consulting on the proposed implementation of a 60mph speed limit between just north of Junction 1 and just south of Junction 2 of the M5.

1.2. Why do we need a 60mph speed limit?

- The M5 motorway is a strategic route for local, regional and international traffic and forms part of the Strategic Road Network (SRN) in England
- This section of the M5 was constructed between 1967 and 1970, and is an elevated section throughout this length
- The 60mph speed limit is part of National Highways programme to improve safety on the SRN. It is expected that the 60mph speed limit will:
 - Limit the speed of vehicles travelling on this route so they would perform more efficiently, reducing emissions
 - This reduction in emissions will aid in reducing the level of nitrogen dioxide (NO2) in this area
- The use of a 60mph speed limit is essential to achieving the objectives above.

2. Legislative changes

2.1. Legislative changes for the implementation of a 60mph speed limit


Subject to the outcome of the consultation, Regulations will need to be made under section 17(2) and (3) of the Road Traffic Regulation Act 1984 ('the 1984 Act') for the implementation of a 60mph speed limit between north of junction 1 and south of junction 2 on the M5.

The Regulations would introduce a 60mph speed limit between north of junction 1 and south of junction 2 on the M5. The point where the 60mph speed limit begins and ends would be clearly indicated to drivers using appropriate signs. The specific sections of road governed by the Regulations will be set out in the Regulations.

The relevant legislative power in the 1984 Act permits the making of Regulations that regulate the way, and the conditions subject to which, motorways may be used by traffic authorised to use such motorways.

Subject to the outcome of the consultation, the proposed Regulations when made will apply only in relation to these sections of the M5 and this consultation is solely about the introduction of a 60mph speed limit on these sections of road.

3. Extent and enforcement of the proposed 60mph speed limit



3.1. Proposed extent of the 60mph speed limit

A map showing the approximate extent of the 60mph speed limit is shown in Figure 1.

3.2. Enforcement

Obtaining an acceptable level of compliance with a 60mph speed limit (displayed on post mounted static sign) is key to the successful and safe operation of the speed limit. No new offences or sanctions will be introduced because of the proposed Regulations.

Enforcement of a 60mph speed limits would be carried out using a combination of the signs, and traditional enforcement by the police. Given the nature of this speed limit, an initial option may be taken by National Highways to write to users who have been identified as exceeding the limit to explain the reason for the limit and encourage compliance.

Appendix A: Frequently asked questions

Q. What is meant by air quality?

A. Air quality for this scheme refers to the level of nitrogen dioxide (NO2) detectable by air quality monitoring.

Q. What is happening?

A. The proposal is to reduce the vehicular speed between north of J1 and south of J2 by implementing a mandatory speed limit of 60 mph along the main carriageway of the M5. The limit is already in place for this project, via a temporary traffic regulation order, but the implementation of the limit via statutory instrument is required as the limit needs to be in place for longer than a temporary traffic regulation order allows for.

Q. Why is National Highways consulting?

A. This consultation will provide an opportunity for interested parties and individuals to comment on the legislative changes required for the implementation of a permanent 60mph mandatory speed limit on these sections of the M5.

Q. Who can respond to this?

A. This consultation is available for anyone to respond to, including organisations that would be affected by the implementation of a permanent 60mph mandatory speed limit. The consultation is aimed at any affected stakeholder groups.

Q. Is the introduction of a permanent 60mph mandatory speed limit likely to be effective?

A. The introduction of a permanent 60mph mandatory speed limit on this section of the M5 will reduce vehicle emissions, helping to achieve the required reduction in NO2 levels.

Q. When is the permanent 60mph speed limit likely to become mandatory?

A. We are hoping to implement the permanent 60mph mandatory speed limit in May 2022.

Q. What is the point of the consultation?

A. National Highways is committed to effective consultation and complies with the Government's Consultation Principles. Effective consultation with affected stakeholders brings to light valuable information which we can use to design effective solutions and mitigate any concerns.

Following the consultation period, issues raised will be responded to where appropriate and a summary report will be compiled providing an analysis of the responses and justification for the selected option.

Q. How are you going to enforce the speed limit?

A. Fixed speed limits are traditionally enforced by the Police.
